To be eligible, you must qualify for one of the following programs:

SSD/SSI

Medicaid
Food Stamps
WIC
TANF
General Relief [GR]
Welfare

You may also qualify if:

- Currently reside in a local Shelter.
- Currently receive unemployment benefits which total less than 200% of the Federal Poverty level.
- Single parent with low income
- Recently lost your job
